- The school is requesting to change our Phased School Reopening Health and Safety Plan, to reflect moving our start date back to November 9th and making the changes outlined in our New Return Plan. (Board Action Requested)

B. Academic Updates: Mrs. McCaughtry (Page 4-5)

- Erie Rise Leadership Academy has been continuously improving its participation/attendance since the first day of school. ERLACS has improved its participation/attendance by 10% from 74% to 84%.
- ERLACS is utilizing Google Classroom as its online learning platform for K-8. Print packet materials are also available for families who do not have internet access or by parent request.
- A Parent Survey was developed by our Principal, Social Work Staff and Board member Dr.
 Smith. The survey was sent electronically via the Rise Facebook and Class Dojo page.
 Additionally, paper copies of the survey were sent home with our students who receive
 Special Education Services that returned to the building.
- Bench Mark Testing will be conducted beginning next week, October 19th for students in grades 3-8.
- A team of Rise staff members have created the Merry Rise Brigade to support staff, build morale and provide comfort to those who experience bereavement and celebrate accomplishments.
